## A RESOLUTION ADOPTING A TITLE VI OF THE CIVIL RIGHTS ACT OF 1964, IMPLEMENTATION PLANFOR THE CITY OF DELPHI

WHEREAS, the federal government enacted Title VI of the Civil Rights Act of 1964, as amended, to prevent discrimination on the grounds of race, color, sex, age, disability, or national origin and to ensure that individuals are not excluded from participation in, denied benefits of, or otherwise subjected to discrimination under any program or activity receiving federal financial assistance of the basis of race, color, sex, age, disability or national origin;

WHEREAS, throughout the years, additional regulations, statutes, directives, cases, and executive orders have been passed which expand the breadth of Title VI;

WHEREAS, the City of Delphi, IN, in recognition of Presidential Executive Order 13672 (4-8-15) recognizes the term "sex" to include "sexual orientation and gender identity" as well as the biological state of being male or female;

WHEREAS, the City of Delphi, IN, by its City Council, wishes to formally adopt and implement the following attached policy and procedure for the benefit of all Delphi's citizens including members of the LGBT population of this City; and

WHEREAS, it is a requirement of the Indiana Department of Transportation and the US Department of Transportation that communities receiving federal financial assistance adopt a Title VI Plan.

NOW THEREFORE be it is resolved by the City Council of the City of Delphi that it hereby adopts the attached Title VI Program and Implementation Plan.

#### **II. PLAN STATEMENT**

This plan was developed to guide the City of Delphi, Indiana, in its administration and management of Title VI-related activities and to establish a policy of non-discrimination in the conduct of its business, including its Title VI responsibilities to the community in which it operates and to the society it serves.

It is the City of Delphi's policy to utilize its best efforts to assure that no person shall, on the grounds of race, color, or national origin, be excluded from participation in, be denied the benefits of, or be subjected to discrimination under its programs, services, activities, and related benefits. Title VI of the Civil Rights Act of 1964 prohibits discrimination based on race, color, or national origin in programs and activities receiving Federal financial assistance. Specifically, Title VI provides that "no person in the United States shall, on the ground of race, color, or national origin, be excluded from participation in, be denied the benefits of, or be subjected to discrimination under any program or activity receiving Federal financial assistance (42 U.S.C. Section 2000d).

Throughout the years, additional regulations, statutes, directives, and executive orders have been passed which expand the breadth of Title VI. The City of Delphi has adopted these tenets and hereby makes the following Plan Statement:

The City of Delphi, Indiana is committed to ensuring that no person is excluded from participation in, denied the benefits of, or subjected to discrimination under any program or activity receiving federal financial assistance from the U.S. Department of Transportation based on race, color, national origin, disability, sexual orientation, gender identity, religion, age, low-income status or limited English proficiency. In the event the City of Delphi distributes federal-aid funds to a sub-recipient, the City of Delphi will include Title VI language in all written agreements and will monitor for compliance. The City of Delphi's City Manager is responsible for initiating and monitoring Title VI activities, preparing reports, and other responsibilities as required by 23 CFR 200.9 Title CFR 21.

#### **III. AUTHORITIES**

Title VI of the Civil Rights Act provides that no person in the United States shall, on the grounds of race, color, national origin, or sex be excluded from participation in, be denied the benefits of, or be otherwise subjected to discrimination under any program or activity receiving federal assistance (23 CFR 200.9, Title 49 CFR 21).

The Civil Rights Restoration Act of 1987 broadened the scope of Title VI coverage by expanding the definition of terms "programs or activities" to include all programs and activities of Federal Aid recipients, sub-recipients, and contractors, whether such programs and activities are federally assisted or not.

### **IV. ORGANIZATION AND STAFFING**

The Mayor, Anita Werling shall serve as the Title VI Coordinator, on behalf of the City Council and the City, and is responsible for the overall management of the Title VI Program to ensure compliance with provisions of the City's policy of non-discrimination with the law.

## V. ACCESSIBILITY (ADA)

Accessibility is necessarily a part of the City of Delphi's Title VI Program as Title VI prohibits discrimination based on disability. The City of Delphi describes its accessibility programs in its ADA Transition Plan available upon request from the ADA & Title VI Coordinator Anita Werling.

The City of Delphi aims to comply with the Americans with Disabilities Act (ADA) and Section 504 of the Rehabilitation Act.

## VI. TITLE VI & ADA COORDINATOR

The Mayor, Anita Werling shall serve as the Title VI Coordinator, on behalf of the City Council and the City, and is responsible for the overall management of the Title VI Program and to ensure compliance with provisions of the City's policy of non-discrimination.

## **VII. TITLE VI/ADA COORDINATOR RESPONSIBILITIES**

The Title VI Coordinator is responsible for implementing, monitoring, and ensuring the City's compliance with Title VI regulations and the overall administration of the Title VI Program and Standard U.S. Title VI Assurances (Assurances: Appendices A-E). This includes the completion of the following activities:

- Program Administration Administer the Title VI Program and coordinate implementation of the City's plan. Ensure compliance with the assurances, policies, and program objectives. Perform Title VI Program reviews to assess and update administrative procedures, staffing, and resources; provide recommendations, as required, to the City Council.
- Data Collection Review and analyze the statistical data gathering process performed by the Title VI Liaison periodically to ensure sufficiency of data for meeting the requirements of the Title VI Program Administration.
- **Training Programs** Conduct or facilitate training programs on Title VI current and new regulations for City employees.
- **Title VI Plan Update** Review and update the Title VI Plan annually (in or by July 1, of each year). Present updated plan to the City Council for approval; submit amended Plan to INDOT as required.
- **Reporting** Conduct reviews of the City's Title VI Program to assess Title VI compliance to assure effectiveness with Title VI provisions. The Title VI Coordinator and the City Department Heads will coordinate efforts to ensure the requirements of Title VI are met.
- Public Dissemination Work with the City Council to develop and disseminate Title VI Program
  information to the City employees and sub-recipients, including contractors, subcontractors,
  consultants, sub-consultants, and the general public. Public dissemination may include postings of
  official statements, inclusions of Title VI language in contracts or other agreements, website
  postings, and/or publication of the City's Title VI Policy Statement in the newspaper. The Title VI
  Coordinator shall ensure adherence to Indiana's Open-Door laws, and, where reasonable requests are
  submitted, provide written or verbal information in languages other than English.
- **Complaints** Administer the complaint procedure, including the filing process, review, and investigation of Title VI complaints that may be received by the City of Delphi, and follow procedural guidelines. Ensure every effort is made to resolve complaints.
- Maintenance Maintain a log of all complaints and an upkeep training log.
- Elimination of Discrimination Work with the City Council to establish procedures for promptly resolving deficiencies, as needed. Recommend procedures to identify and eliminate discrimination that may be discovered in the City's processes.
- **LEP Plan** -- Develop and implement the City of Delphi's Limited English Proficiency (LEP) Plan. Train City Employees on the procedure to follow when a person requests an interpreter.
- **Contract Compliance** -- Establish procedures for reviewing contracts with sub-recipients, special interest programs and activities to include the Title VI Assurances;

- **Collection of Data** Collect statistical data, where available, on the impact of applicable construction projects on the different classes described in the Plan Statement;
- **Continuing Education** -- Attend Title VI Training as necessary. Maintain logs of training attendees.

## VIII. DEPARTMENT HEAD RESPONSIBILITIES & DEPARTMENT HEAD REPORTING

The City of Delphi employees will be expected to follow Title VI policy and the guidelines set forth. In addition, City of Delphi employees should make every effort to alleviate any barriers to service or public use that would restrict public access or usage, take prompt and reasonable action to avoid or minimize discrimination incidences and immediately notify the Title VI Coordinator or department head, in writing, of any questions, complaints or allegations of discrimination. Department heads are responsible for:

- Ensuring applicable City contract documents contain the appropriate Title VI provisions;
- Consulting with the Title VI Coordinator when Title VI complaints are received or issues arise;
- Comply with the Plan Statement;
- Develop and update internal policies and procedures to ensure Title VI compliance during all phases of projects, activities, etc.;
- Ensure all business pertaining to the selection, negotiation and administration of applicable consultant contracts and agreements is accomplished without discrimination as set out herein;
- Provide information in the appropriate language or interpreters as needed for individuals with disabilities and LEP persons.

Department heads should complete Title VI Review Forms and submit them to the Title VI Coordinator. Review Forms will be used as an assessment tool to determine compliance within the departments with Title VI. Title VI Coordinator may provide training to help the Department Heads achieve its Title VI goals and better assist to alleviate discrimination. The Title VI Coordinator will review the data collection procedures for each department periodically to ensure compliance is met with the City of Delphi's Title VI Program requirements. The Department Heads should prepare the report and submit it annually on or around **June 1st of each year**. The following information should be included in each annual report submitted:

- Number of federally funded projects awarded during the past year;
- Number of Title VI complaints received during the past year, Statistical data collected on ethnicity, race, gender, and disability for all right-of-way relocates.

- Affirmation that staff understands the Title VI Policy and procedures set in place for the City.
- Information related to the public dissemination of the Title VI Policy or Policy Statement.
- Information on several individuals who received Title VI training in each department including attendees, dates, and locations.
- Information on several LEP persons needing assistance including services used related to cost, and a description of the communication needs of LEP persons.

## IX. TRAINING

The Title VI Coordinator will make Title VI Program training available to employees, contractors, sub-recipients, and Department Heads. The training will be documented on the Training Log (Attachment B).

The training will provide information on Title VI provisions and operation, and identify Title VI issues and resolution of complaints. A record of the training conducted will be kept by the Title VI Coordinator.

## X. LIMITED ENGLISH PROFICIENCY (LEP) PLAN

This Limited English Proficiency Plan has been prepared to address the City of Delphi, Indiana's responsibilities as a recipient of federal financial assistance as they relate to the needs of individuals with limited English language skills. The plan has been prepared in accordance with Title VI of the Civil Rights Act of 1964, U.S.C. 2010. It implements regulations that provide that no person shall be subjected to discrimination based on race, color, or national origin under any program or activity that receives federal financial assistance.

Presidential Executive Order No. 13166, titled *Improving Access to Services for Persons with Limited English Proficiency*, indicates that differing treatment based upon a person's inability to speak, read, write or understand English is a type of national origin discrimination. It directs each federal agency to publish guidance for its respective recipients clarifying their obligation to ensure that such discrimination does not take place. This order applies to all state and local agencies which receive federal funds, including all City of Delphi's departments and divisions receiving federal grant funds.

#### Language Assistance

A person who does not speak English as their primary language and who has a limited ability to read, write, speak or understand English may be a Limited English Proficient person and may be entitled to language assistance with respect to the City of Delphi's programs and activities. Language assistance can include interpretation, which means an oral or spoken transfer of a message from one language into another language and/or translation, which means the written transfer or a message from one language into another language. The City of Delphi will determine when interpretation and/or translation are needed and are reasonable. The City of Delphi staff shall consider the following to identify if an interpreter is needed or if an LEP person needs language assistance:

- Examine records to see if requests for language assistance have been received in the past, either at meetings or over the phone, to determine whether language assistance might be needed at future events.
- Have Language Identification Flashcards (Attachment C) available at City Hall and other City venues near customer service areas, easily accessible to the staff. Individuals selfidentifying as persons not proficient in English may not be able to be accommodated with translation assistance at the time, but it will assist in identifying language assistance needs for future events.

#### Language Assistance Measures

The 2021 World Population Review indicates Delphi, IN has a population of 16.79% that also speak a "Language other than English." Residents of The City of Delphi that are LEP individuals, that is, persons who speak English "not well" or "not at all", the City of Delphi will strive to offer language assistance using the following measures:

- If an individual asks for language assistance and the City of Delphi determines that the individual is an LEP person and if language assistance is necessary to provide meaningful access. The City of Delphi has the discretion to determine whether language assistance is needed, and if so, the type of language assistance necessary to provide meaningful access.
- When an interpreter is needed, in person or on the telephone, staff will attempt to determine what language is required and access the language interpreting service to be used.
- The City of Delphi will periodically assess the need for language assistance based on requests for interpreters and/or translation.

#### **XI. COMPLAINT PROCEDURES**

#### Overview

Title VI of the Civil Rights Act of 1964, as amended, and with its related statutes and regulations, prohibits unequal treatment or discrimination. Any person who believes they have faced unequal treatment or discrimination as to the receipt of benefits and/or services based on their race, color, national origin, disability, sex, sexual orientation, gender identity, religion, age, low-income status, or limited English proficiency, has the right to file a complaint as described herein. Complaints should be filed with the City of Delphi, Indiana's Title VI Coordinator.

These procedures cover all complaints filed under Title VI of the Civil Rights Act of 1964, Section 504 of the Rehabilitation Act of 1973, Civil Rights Act of 1987, the Americans with Disabilities Act of 1990, and other relevant regulations, statutes, directives, and Executive Orders relating to any federally-funded contract or activity administered by the City. It also applies to sub-recipients, consultants, and contractors. Intimidation or retaliation of any kind is prohibited by law.

The procedures do not deny the right of the complainant to file formal complaints with other state and federal agencies or to seek private counsel for complaints alleging discrimination. Every effort will be made to obtain early resolution of complaints at the lowest level possible. The option of informal mediation meeting(s) between the affected parties, the Title VI Coordinator, and the Department Heads may be utilized for resolution.

#### Who May File a Complaint?

Any individual, group of individuals, or entity that believes they have been subjected to discrimination prohibited by the above-described nondiscrimination requirements may file a written complaint with the City of Delphi's Title VI Coordinator. A formal complaint must be filed within 180 calendar days of the alleged occurrence.

(See Attachment D for Discrimination Complaint form).

#### **Complaint(s)** Timeliness

For a complaint to be considered timely, complaints must be filed within 180 calendar days after the alleged incident. The filing date of a complaint is the earlier of the postmark or date received by the City of Delphi.

#### Location/Availability of Complaint Forms

The City of Delphi will make complaint forms available via the City's Website. Persons may contact the Title VI/ADA Coordinator to request a copy of the complaint form via e-mail, United States mail, or by other means offered by the City. Copies of complaint forms are available in alternative formats upon request.

#### How to File a Complaint

A complainant may file his or her complaint by mail, email, or drop off with the Title VI Coordinator. The City of Delphi will acknowledge complaints received and will process them once the City establishes the complainant identity. Complainants must mail a signed, original copy of the fax or email transmittal to the City to begin the complaint process. The City of Delphi does not require a complainant to use the City Complaint form for submitting his or her complaint.

If the person alleging the complaint is unable to or incapable of providing a written statement, a verbal complaint may be made to the City of Delphi's Title VI Coordinator. Under these circumstances, the person filing the complaint will be interviewed and the City of Delphi's Title VI Coordinator will assist in completing a written statement. Within fifteen (15) calendar days after receipt of the complaint, the Title VI Coordinator will arrange to speak or meet with the complainant to discuss the complaint and the possible resolutions if applicable.

### **Complaint Processing**

The Title VI Coordinator will review the complaint upon receipt to ensure that all required information is provided; the complaint meets the filing deadline date, which is 180 days from the date the alleged discriminatory act occurred and falls within the jurisdiction of the City.

The Title VI Coordinator will then investigate the complaint. If the complaint is against the City, then the City Council or their designee will investigate the complaint. Additionally, a copy of the complaint will be forwarded to the City Attorney.

If the complaint warrants a full investigation, the Complainant will be notified in writing by certified mail. This notice will name the investigator and/or investigating agency.

The party alleged to have acted in a discriminatory manner will also be notified by certified mail as of the complaint. This letter will also include the investigator's name and will request that this party be available for an interview.

Any comments or recommendations from legal counsel will be reviewed by the Title VI Coordinator, City Council, and City Manager's office.

Once the City has investigated the report findings, the City will adopt a final resolution.

All parties associated with the complaint will be properly notified of the outcome of the City's investigative report.

If the complainant is not satisfied with the results of the investigation of the alleged discriminatory practice(s), she/he shall be advised of their right to appeal the City's decision. Appeals must be filed within 180 days after the City's final resolution. Unless new facts not previously considered come to light, reconsideration of the City's determination will not be available.

The foregoing complaint resolution procedure will be implemented in accordance with the Department of Justice guidance manual entitled "Investigation Procedures Manual for the Investigation and Resolution of Complaints Alleging Violations of Title VI and Other Nondiscrimination Statues," available online at www.justice.gov.

The Title VI Complaint Filing – Complaints filed with the City of Delphi, Indiana, based on violations of Title VI of the Civil Rights Act of 1964, must include the following information:

- Name of Complainant
- Address of Complainant
- Name of Agency / Department Accused of Discriminatory Practices
- Address of Agency
- Description of Alleged Discrimination

- Date of Complaint
- Telephone Number of Complainant
- Name of Individual Accused of Discriminatory Practices
- Date of Alleged Discrimination

Attachment D provides a sample complaint form that may be used for this process.

**Explanation of alleged discrimination** – Please explain as clearly as possible what happened. Provide the name(s) of witness(s) and others involved in the alleged discrimination. (Attach additional sheets if necessary and provide a copy of written material pertaining to your case.) Include the signature of the complainant and the date of complaint.

**Note:** The City of Delphi prohibits retaliation or intimidation against anyone because that individual has either taken action or participated in an action to secure rights protected by policies of the City. Please inform the Title VI Coordinator if you feel you were intimidated or experience perceived retaliation in relation to filing a complaint.

Following receipt of the complaint of alleged discriminatory acts, the City of Delphi's Title VI Coordinator will send the complainant a letter of acknowledging receipt by the City of the Complaint.

If, after investigation, the City determines that the filed complaint alleging a Title VI violation has been substantiated, the City shall notify the complainant of such determination and that the City has implemented measures to correct the issue. Such notice shall also indicate that the complainant may be notified again by the City, state, or federal authorities if an administrative hearing process is initiated.

If, after investigation, the City of Delphi determines that the filed complaint alleging a Title VI violation has not been substantiated, the City shall notify the complainant of such determination and that the City is closing the file for the issue. Such notice shall also indicate that the complainant has the right to:

- 1. Appeal within seven (7) days of receipt of this final written decision from the City, and/or
- File a complaint externally with the U.S. Department of Transportation, Indiana Department of Transportation (INDOT), and/or the Federal Transit Administration Office of Civil Rights Attention: Title Program Coordinator East Building, 5<sup>th</sup> Floor – TCR 1200 New Jersey Ave SE, Washington DC, 20590.

## **XII. RECORDS**

The Title VI Coordinator will maintain all records of an investigation for the amount of time dictated by the State's Record Retention Schedule (INDOT recommends retaining records for three years.)

## XIII. PUBLIC PARTICIPATION AND OUTREACH

The City of Delphi is committed to ensuring that community involvement and outreach are done in a respectful and appropriate manner that will allow for diverse involvement. Public meetings, programs, and activities will provide equitable opportunities for participation. Any meetings that are open to the public are published on the main page of the City of Delphi's website and distributed to local media outlets. The Title VI Coordinator will update the City's webpage, to include pertinent Title VI information as it becomes available.

All City of Delphi's public meetings are held in locations accessible to individuals with disabilities. Various meeting agendas, meeting minutes, City of Delphi notices, events, and news can be found on the City's website.

## **XIV. TITLE VI CIVIL RIGHTS COMPLIANCE REVIEWS**

The City of Delphi, Indiana shall perform annual reviews to determine overall compliance with its Plan Statement, including performing annual reviews through interviews and document reviews within each department. In addition, the City has adopted these 2022 goals set out in **Program Goals Attachment 1**.

## **XV.SOCIAL EQUITY AND ENVIRONMENTAL JUSTICE**

Ensuring the meaningful involvement of low-income, minority, disabled, senior, and other traditionally underrepresented communities is a key component of the City's public participation activities. The City of Delphi's policies, procedures, and programs are consistent with federal and state environmental justice laws, regulations, and requirements, Title VI, related nondiscrimination requirements and reflect the principles of social equity and environmental justice. Social equity means ensuring that all communities are treated fairly and given equal opportunity to participate in the planning and decision-making process, with an emphasis on ensuring that traditionally disadvantaged groups are not left behind. Environmental justice means ensuring that plans, policies, and actions do not disproportionately affect low-income and minority communities. The three Fundamental environmental justice (EJ) principles are:

- To avoid, minimize, or mitigate disproportionately high and adverse human health and environmental effects, including social and economic effects, on minority populations and low-income populations;
- To ensure the full and fair participation by all potentially affected communities in the transportation decision-making process; and
- To prevent the denial of, reduction in, or significant delay in the receipt of benefits by minority populations and low-income populations.

The City of Delphi is committed to these three environmental justice principles in all work that the City performs.
