

Application for City of Delphi SMALL BUSINESS RESILIENCE GRANT DRAFT

Do not delay in submitting applications! Funds will be awarded quickly. Maximum grant amounts are \$5,000 per business, based on demonstrated need. This is not a loan.

Eligibility:

Businesses eligible for a Delphi Small Business Resilience Grant must meet the following requirements:

- Must be in good standing with regard to state and local taxes, licenses and code compliance.
- Must be in good standing with the Indiana Secretary of State.
- Must have been established and operational in the City of Delphi since January 1, 2020. Businesses that have expanded to a storefront from another business are eligible (e.g., an established caterer who opened a restaurant or an online retailer who opened a boutique).
- Eligible uses of funds: payroll (exclusive of owner compensation), utilities, rent, mortgage payments, insurance, or similar expenses, and products directly used in production of a product for sale.
- Have 25 or fewer full and part time employees.
- Must not be a governmental unit.
- If non-profit, must be a 501(c)(3) organization.
- Owners of multiple within the City of Delphi are eligible for *each* business that meets these criteria.
- Preference will be given to businesses that have:
 - demonstrated a commitment to the community, through support of local youth or charitable programs, good corporate citizenship, participation in community and business support organizations;
 - plans to hire, train or assist individuals who lost jobs or experienced economic hardship during the COVID-19 crisis;
 - o an inability to pay rent, utilities, overhead, and supply costs;
 - increased costs based on social distancing or other public health restrictions;
 - length of time within the City of Delphi;
 - o unmet needs that have not been or are not anticipated to be addressed through the Small Business Administration (SBA) Disaster Loan Program or through other government assistance programs;
 - o not received abatements or incentives from the city previously;
 - made all reasonable efforts to keep employees employed during the recovery process.

The Delphi Small Business Resilience Grant program has limited funding, therefore not all grant requests may be approved or approved at the level requested. Applications will be reviewed and kept confidential by the selection committee, which will consist of the five members of the Delphi Common Council.

Review Process:

- Applications are due by 4:30 p.m. EDT on Friday, April 24, 2020.
- Applications will then be reviewed by a selection committee.
- Applications will be reviewed during the week of April 27 May 1. Awards will be announced the week of May 4
 and payments will be disseminated no later than Thursday, May 7, 2020.
- If funding allows, additional grants may be processed and awarded on an as-needed basis.
